General Comments:

The IRS form 990 is a comprehensive overview and the official statement of the business of delivering excellent television, media and education resources to the residents of our region. The FYE 2020 990 covers our fiscal year from September 1, 2019 to August 31, 2020. Our fiscal year is based on the school year because Spokane Public Schools owned our FCC license until 2013 when the Friends of KSPS 501 c3 corporation took over ownership.

Page 1, line 12: Total revenue \$5,526,655 (\$4,991,422 FYE 8/31/2019)

Page 1, line 18: Total expenses \$5,144,535 (\$5,061,103 FYE 8/31/2019)

Page 1, line 19: Revenue less expenses: \$465,552 (-\$153,113 FYE 8/31/2019)

Page 6, Section B: KSPS is in full compliance with Governing Body and Management Policies and Disclosure standards.

Assessment:

Return on Investment (ROI) = total administrative and fundraising expenses / revenue
 $892,031 / 5,526,655 = 0.161 \times 100 = 16.1\%$ of our revenue is spent on administration. \$4,634,624 went to pay the bills to produce and broadcast the shows you love and fund our educational outreach to our region.

Additional information:

Page 11, Part X, line 2: Savings and temporary cash investments: \$2,472,112 are held in an account to meet reserve requirements and pay the bills in the event of a severe fiscal crisis.

Schedule A, page 14, section c, line 14: percentage of public support: 98.29%. A 501(c)(3) corporation must achieve 33.3% to maintain their status. This number reflects our broad community support.

Schedule B, page 22, The Corporation for Public Broadcasting Grant to KSPS: \$1,270,033. These are your federal tax dollars at work. This grant is a 0.28 match based on our funds raised.

KSPS received CARES Act Funds from the CPB: \$260,205.

PPP Funds were not forgiven as of August 31, 2020. It is on our books as a loan/liability in this 990. KSPS was in full compliance and the loan was forgiven in September, 2021. The funds will show as revenue in our next 990.

The KSPS Endowment:

Schedule D, part V: The KSPS Endowment, held by Washington Trust Bank grew to \$984,104 (\$98,482 in contributions from estate and planned gifts, \$52,546 in investment income, FYE 8/2020). The Endowment distributed \$29,579 to KSPS operations (4%, 13 quarter trailing average). Endowment management policies are available upon request, please contact Sandra Kernerman, CFRE, Investment & Partnership Director, (509.443.7717 or sandrak@ksps.org). In September 2020, at the beginning of the new fiscal year, the fund exceeded \$1,000,000: a most welcome milestone. KSPS has a beneficial interest in an inactive fund at the Innovia Foundation, (page 23, part XI), valued at \$674,254. Distributions from the fund are deposited in the KSPS Endowment at Washington Trust Bank or, with Board approval, used to support KSPS operations. The Innovia distribution was deposited in the WTB Endowment in the 2019-20 fiscal year.

Summary:

Despite the grievous economic impact of the Covid-19 pandemic on our viewing region, our supporters issued a vote of confidence in KSPS PBS by continuing and expanding their support. We also credit the implementation of our new business plan for guiding our management to create focused and relevant services to our region during the covid emergency.
