### Terms & Conditions

MANY WILL ENTER, FEW WILL WIN. NO PURCHASE NECESSARY TO ENTER OR WIN. The MontanaPBS (PBS) Good Neighbor Writers Contest (the "Contest" or "Promotion") is produced by MontanaPBS and based on a promotional conception from the station. The Contest begins on or about February 14, 2019, and ends on or about March 14, 2019. Announcement of winners will take place on or around April 6<sup>th</sup> at our Independent Lens documentary screening event. ### Eligibility & Entry Guidelines

- Entrants must be children/young adults in Pre-K through 12<sup>th</sup> grade.
- Entrants will be grouped for judging by categories: Pre-K, K, 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>-5<sup>th</sup>, 6<sup>th</sup>-8<sup>th</sup> and 9<sup>th</sup>-12<sup>th</sup>
- Grade categories will be provided unique prompts at the discretion of MontanaPBS. See the Contest Description PDF or visit [montanapbs.org/writingcontest](http://montanapbs.org/writingcontest).
- Children of employees of MontanaPBS and judges are not eligible.
- To be eligible, an entrant must be a resident in Montana. MontanaPBS reserves the right to disqualify ineligible entries.
- Only one entry per person will be accepted in this Contest; all subsequent entries will be disqualified.
- Only single-author stories qualify (no co-authored stories).
- Stories can be prose or poetry.
- Any failure to adhere to these Contest Rules may result in disqualification from the Contest.
- No purchase is necessary.

### Content Requirements

- Limit content to 4 double-spaced pages.
- Text must be printed or written legibly or typed.
- Those who cannot write may dictate their story to be printed, written legibly or typed.
- Accompanying illustrations, designs, or graphics are permitted but not required.
- Non-English text must be translated on the same page.

- Invented spelling is accepted.

#### Official Entry Form

- To enter you must fill out and submit the 2019 Writing Contest Entry Form located at [montanapbs.org/writingcontest](http://montanapbs.org/writingcontest). For mailed entry, print off and fill out the offline entry form. It must contain the required signature, confirming that the story and art are original, and granting certain rights to the entry materials. A parent/guardian signature must be present on either form.
- The entry form must be complete and legible to be eligible.

#### Judging, Awards & Notification

All entries submitted to the Contest will be judged using the judging criteria and percentages below by a panel of no fewer than 3 judges selected and coordinated by MontanaPBS. Judging will occur on or about March 18, 2019. The judging criteria and percentages shall be scored and graded using a rubric based on the following criteria:

- 50% Clear understanding of the prompt
- 30% Story structure and writing skills
- 20% Authenticity in writing

All decisions of the judges are final and binding and not subject to appeal or review. Winners will be as follows: (1) the entry with the highest score from among all eligible entries received per grade category will be deemed a First-Place winner.

#### Prizes

Prizes include certificates of award, toys, apparel, and any other general PBS merchandise. First place winners will receive a custom certificate of award, and merchandise at the discretion of the Contest administrators. Potential winners will be notified by MontanaPBS in early April. Prize recipients must allow a minimum of 4 to 12 weeks from notification to delivery. Prizes are non-transferable and non-substitutable, and are not redeemable for cash.

#### Return of Entries

The Contest administrators are not required to return mailed entries. Only when specifically requested, Contest administrators will mail back entries. Please ensure that mailing addresses are correct and, if handwritten, legible. MontanaPBS is not responsible for late, lost, stolen, misdirected, damaged, mutilated, incomplete, returned, or illegible entries, or postage-due mail.

#### Rights Associated with Contest

All the following rights and conditions apply to the parent/guardian that signed on behalf of the under 18 participants. Submission of the Entry Form constitutes permission from the participant for MontanaPBS to use the participant's name, likeness, biographical information and materials contained in the Entry Form, photographs, videos, and any statements or remarks made about the Contest in advertising and promotion without further compensation or permission, except where prohibited by law. All entries, and any copyrights therein, become the sole property of MontanaPBS. By entering, entrants agree to abide by the above stated rules,
